Stephanie gave the group an update on the AFSP policy day at the Capitol. She shares that her personal story makes a big impact. She met with Rep. Salinas, Rep Kotek, Sen Frederick. Rep Kotek looking for support. Rep. Salinas asked for more information. Stephanie explained our strategy of building towards requiring education for health care as well.



Rep. Salinas likes the idea of a stepped process – beginning with behavioral health workforce then move on to health. Julie notes that she is a tremendous advocate. Rep. Salinas is head of the healthcare committee.

Stephanie shared background of efforts to pass broad education requirements for healthcare workforce which failed due to opposition.

Julie agrees with the incremental approach to move this forward. It will take a campaign to work towards requiring physical health providers require training. Julie notes that the Oregon Medical Association actively opposed.

Amber suggests that courses on suicide could fulfill ethics requirements.

Tanya-views it as unethical for substance abuse providers to be treating adolescents without any training on suicide prevention. Tanya sees a gap for adolescent in and out-patient treatment. She hopes that all of the adolescent treatment center has

		something in place and believes it should be part of MACBO's ongoing requirements. Mental Health and Addiction Counselor Certification Board of Oregon. Next meeting is in April.
		Fran-This should be a foundational aspect of clinical training. When I think about mandatory trainings in child abuse, sexual abuse the focus is on protection and safety of training. Suicide prevention/intervention should be seen as a safety issue as well.
		Action: Annette/Shanda/Amber – A team of two will go to Portland to meet with MACBO and discuss requirements for suicide prevention/intervention in April.
		Julie-reminds us that it is important to work as a team and be strategic regarding the stepped process of advocacy so legislators and others get a consistent message from the Alliance.
