2:30	Welcome, Announcements, Consent Agenda Galli Murray	<p>Galli was delayed, Charlette chaired with support from Annette.</p> <p>Announcements:</p> <ul style="list-style-type: none"> ▪ Laura Rose – the legislative concept (LC) for the ASIPP is moving forward; focus is ASIPP advisory council and coordination. ▪ Elissa – Sandy Bumpus, Family Support Network, will serve as co-chair of the Data & Evaluation Committee; the committee is looking for an additional leader from the county level. Annette confirmed Sandy will be a voting member of the executive committee. ▪ Annette – Michelle Bangen and Angela Perry will co-chair the Equity Advisory. <p>Consent agenda: Motion to approve November meeting minutes – Justin; second – John. Minutes approved.</p>
2:40	Alliance Project Tracker Review	<p>Project plan can be found here.</p> <p>Annette – the planner needs to be updated, missing Jenn’s help with this. The updates are primarily related to the work of committees.</p> <p>Annette reported the funding for mini grants to coalitions has come through. Funding had been stuck at OHA due to issues around contracting/funding source. Annette thanked Jill, Shanda and Meghan for going to bat for the AOCMHP/Alliance to receive the funds. Highlights include:</p> <ul style="list-style-type: none"> • Mini-grants for coalition approved through Public Health/HSD Collaboration • AOCMHP/Alliance will administer and Alliance/UO will partner for evaluation • Alliance will consult the Coalition Leaders Group re: eligibility criteria and scope; \$417,338 available to distribute to coalitions across state • Quick turn-around – funds are to go out within 2 weeks of awards • Coalition activities can occur after June

<p>Schools, Equity and Workforce</p>	<ul style="list-style-type: none"> • LC is back from Sen. Gelser’s office. Focus is requiring OHA to develop/provide a 6-hour course for medical personnel; training is a complex task given the range of professions within the medical community. Committee will pursue required training/CME at later session. • Alliance participating in HB2315 rules development; evaluation of how BH workforce is complying with required training is challenging. LC adjustments will be forthcoming over the next few months. • Don reported that over 8,000 DHS employees have been trained in QPR, several hundred opted out; next year the total will be over 10,000 trained. Considering taking the training statewide to all state agencies; as part of the negotiations, SCIU requested. Skills used with clients and staff to staff. John Seeley asked about surveying employees re: skill application, Don will discuss with his team. <p>Schools – Justin and Claire</p> <ul style="list-style-type: none"> • Four presentations re: Adi’s Act implementation have been made including one for the School Board Association and Suicide Prevention conference • Committee has been focusing on monitor Adi’s Act implementation through a review of progress as posted district/schools websites. • Committee members participating in the rule making process. <p>LGBTQ+ Advisory – Annette</p> <ul style="list-style-type: none"> • Annette is helping with a grant application the Oregon Family Support Network and the Family Acceptance Project are submitting. Grant is for 6 months, focus is webinars/printed materials for school staff re: family acceptance/LGBTQ+ youth. change approach of school staff and families when talking about. • Helping with the grant is an example of Alliance supporting its partners and how the Alliance is becoming an incubator for innovative approaches to suicide prevention. • Mavis Gallo is working on the evaluation component. <p>Lethal Means Advisory – Annette</p> <ul style="list-style-type: none"> • BM114 passed, short-term impact is an increase in gun sales due to language re: permit requirement. It is being challenged in court, implementation could be delayed. • Annette requested Lethal Means Advisory move to committee status; advisory leadership supports, polling advisory members

<p>3:20</p>	<p>Policy Updates</p>	<p>Annette reported policy updates, items to be added legislative information flyer and Alliance position on proposed legislation:</p> <ul style="list-style-type: none"> • Budget Forecast: Will not be as robust at last budget of \$28B, closer to \$25B; may not gain new funding, anticipate maintaining current level for suicide prevention. • Basic Rights OR is putting forward legislation re: gender affirming care; pediatric field is supporting. Annette asked is there was any objection to the Alliance including on the leg one pager, Alliance position, support. No objections. • OR Education Association – LC to require all districts to participate in Healthy Teen Survey and SEED; currently only 32% participate now. Justin shared that we should anticipate push back from teacher, reason is it takes time out of instruction. Also some concern on the part of districts re: potential negative indifference liability in how they respond/attend to data from survey. Alliance position, collaborate. • OHA – POP items: SOGI data, Alliance position, support. ASIPP, Alliance position, support. Discussion on ASIPP: Shandra initial thinking re: the overlap between YSIPP and ASIPP for 18-24 yr. olds – YSIPP will cover college; ASIPP, vocational/training areas. At the quarterly meeting, Jill will review 2023 YSIPP initiatives and more detail for this population. • 988 Trust Fund – funding to cover crisis line and mobile response; Alliance position, support. • Capital Day is Feb. 13, 2023 • Meeting with legislators is more difficult until their committee assignments are finalized • Policy information will be shared in packets for SP Coalitions
