Looks like Friday is the best option for everyone, but we may need to do different Fridays. Annette will check her schedule and get back to us on a set time.</p>
9:10	Next Steps HB2315 – Note suggested language for new initiative: Monitor implementation of HB2315 and, if needed, advise OHA on steps to improve access and quality of trainings for relicensure.	<p>Review any feedback for public rules meeting at 11. Discuss how we will monitor HB2315 including potential evaluation plan.</p> <p>Stephanie pointed out that the boards already get a lot of money so the wording around this is off. Annette points out YouthSAVE is not required- team revisited again later and determined this created new bucket of expenses so we want to get rid of it. (page 3, 1 (b))</p> <p>Team discussed usage of “suicide management” and agreed “management” is not the appropriate term. Suggestions include “ongoing support for suicidality,” “long-term supports,” etc.</p> <p>Team agrees “safety planning” should include a note on lethal means counseling/planning as it may not be clear to people whether “safety planning” includes those topics or not.</p>
