



Alliance Vacancies

Here is our current timeline for membership applications:

- March April: Nominations accepted
- May: Nominations reviewed and voted on by Executive Committee
- May: Send approved Nominations to OHA for final approval
- June or September Quarterly: New members recognized during our full Alliance Quarterly Meeting

2023 Legislation Tracking

HB 2656 - Requirement for specified surveys (Student Health, SEED). No movement since hearing on 2/8. Significant opposition testimony. Nothing scheduled.

SB 514 - Establishment of adult suicide prevention coordinator with OHA (ASIPP). 3/7 referred to Ways and Means. Nothing scheduled.

HB 2643 & HB 2646 - requires SDs to develop, review and revise individualized suicide prevention protection plans; ODE to provide training program for wide range of MH concerns, designated MH point of contact in every school identified. No movement since 2/8 public hearings

HB 2757 - Expansion of 988 funding for coordinated crisis services systems. Work session held on 3/13. Do-pass 6 to 5, referred to House Revenue

SB 818 - Suicide risk/tx continuing ed opportunities (list provided by OHA) for specified health care providers. Work session held on 3/1.

SB 549 - School-based (mental) health center grants; wraparound service delivery hubs (pilot). Public hearing scheduled for 3/16 at 3pm.

HB 3513 - Firearm transfers, storage. 3/3 referred to judiciary. Nothing scheduled
