			HB 3513 Update: There were concerns over part of the legislation that a
			large group had which was brought to the reps. As a result of this, the bill
			is not moving forward. Concerns were over giving the firearm to someone
			else in times of a crisis as they were worried that this would open
			loopholes for people around gun transfers even though this legislation did not refer to firearm transfers.
			Jonathan and Pam update: OPAT Conference – Bringing together people
			across the state who have historically and currently done substance use /
			opioid work. They were able to find a couple of panelists to participate in
			this workshop. They believe that the topic and presentation was elevated
			to a keynote presentation at OPAT from a workshop session. Presentation
			will look at prevention and postvention efforts in deaths of despair.  Conference is taking place in person in May in Sunriver.

			Some funding was found to help provide supports in rapid response for
			suicide deaths involving veterans. This limited funding is for this specific
			year for anyone within the veteran community. Money earmarked to
			purchase lockboxes throughout the Oregon veteran population. Have
			heard from the veteran community:
			- Locks are okay but storage and lockboxes are more effective and
			tend to incentivize family members and other veterans to
			participate in these conversations.



			Annette shared that AOCMHP received funding for the next two years to provide lockboxes through the Alliance.
