9:30	Welcome, Announcements, Consent Agenda	Table items that have not been resolved Returning members: <i>Put name & organization in the chat.</i> New members: <i>Share name & organization with the group.</i>	<p>Jill shared that there is a delay in CDC data being released. They usually release data mid-February / early-March. They have released one set of data but it is not what OHA has historically used. Instead of using that set and it not matching previous years, which may cause confusion, they have decided to wait for the data set they usually use to drop. OHA anticipates a press release to talk about good news on youth suicide trends for 2021. <i>Preliminary data</i> shows that this trend of decrease <i>may not</i> continue into 2022.</p> <p>Shanda shared last year's annual report which can be found here.</p> <p>Taylor shared the injury fatality data glossary which can be found here.</p>
9:35	Small Group Introductions		Attendees broke into small groups of 3 to talk more about data related things and get to know one another.
9:45	YSIPP Metrics Presentation Jill Baker John Seeley UO Lab		<p>Jill shared a document that is incomplete / in progress around YSIPP metrics. She shared that they are looking at two questions as it relates to the initiative level of the YSIPP -</p> <ol style="list-style-type: none"> 1. Where are we at with implementation? 2. How do we know what we are doing is working? <p>John shared that they will eventually want to know impact measures but right now they are just looking at implementation and process metrics.</p>

UO Lab team is working on metrics with the YSIPP to see how we want to measure different things in the plan. Right now, the team is working on a data glossary.

John shared that the presentation last month from Colorado was very helpful to see how they organize metrics by process vs. outcome vs. impact.

Jill said that one strategy they are looking at now is the Big River Training initiatives as they have more evaluation around these. They are laying out what they have already (are they process or outcome metrics) for the programs. They are asking what we want to know that we don't for process and outcome metrics. A Data Repository software for Big River training programs is in progress so they can analyze the data and see what's happening, what's involved, what is missing.

It was suggested that we create good definitions for pathways. This project started but will take some time. The OHA S-PIP team has a retreat in April that has this on that agenda item. Jill said that it would be nice if she could bring the draft of the definitions back to this committee for feedback.

John said that there are some terms in the document that we need to unpack. Example: skill acquisition can have many meanings that they need to get more specific on.

			<p>John said that they want to crosswalk between Colorado report and what we do.</p> <p>Jill said that one outcome of this process is meshing words from social work, research, evaluation, and other specific languages from different professions.</p> <p>Jill said she wants to bring the data repository staff from OHA to this committee in the future to present and get our feedback. John said it would be good for us to be used as a usability test group for the repository team so they can know how accessible it is.</p> <p>Annette asked about PSU – they are also evaluating different buckets of information. How are we integrating that data into what we are doing with the YSIPP? Jill said it’s not separate and is reported the same in the annual YSIPP Report. The places of intersection are</p> <p>They have a chart of what they can consistently track across different trainings that are evaluated by the UO team.</p>
10:30	<p>Outreach Plan and Request for Committee Assistance Elissa Adair</p>		<p>Elissa shared that a goal is to have data people spread across the state so that we have people at the local level who are not data shy and can engage with data when new dashboards come out. She is hoping we can brainstorm what next steps could be on how we can encourage engagement in both this committee and data in general.</p>

Jill asked if counties have public health epidemiology people that we can recruit. John believes that the larger counties would have these positions.

John asked if we could use the coalition grants as a way to recruit for this committee. Annette said that she is currently creating a format for the learning collaboratives and that some of the sessions are going to talk about data. Kathy said that should also think about how this links with the creation of strategic plans and alignment with state plans – YSIPP and ASIPP.

It was acknowledged that creating a strategic plan is a big project. It took Clackamas County about 5-6 years to have a final plan to share and this was with intensive technical assistance from the UO team.

Elissa asked if this committee could be invited to one of the coalition learning collaborative? Should this committee create a learning collaborative? Annette said that we are going to start by getting to know the coalitions and then will most likely do a session around data and find out what is most interesting to them on what they want to pursue.

Elissa asked if we should each identify someone to invite to a future committee meeting remembering that it is about quality not quantity of attendees. Kathy suggested that we create a one-pager about this committee – who are we looking for to join the committee, what do we do, why it is important for them to

join us. Elissa will draft this, send to Kathy for review, and bring to committee next month.

John suggested that we think about different sectors and how to get them to the table – schools, health services, CCOs, etc. Elissa said that it was an original goal for this committee to cross with other committees.

Kathy suggested that we could also engage people at specific meetings around specific topics if doubling up for two committees creates a barrier -- and ask Colorado how they did this. Elissa suggested two meetings a year for committee chairs to attend to talk about data needs. Another option – we start to circulate to different committee meetings to get a sense of what data challenges and need are.

Jill asked if we want to have a longer work session in late summer to look over finalized data, dashboards, etc.

- Regional coalitions, potentially leveraging the coalition grants

Potential tasks for Data & Eval Committee (brainstorm ideas)

- Catalog a list of data sources.
- Learning collaborative for people working in suicide prevention who are working in data, best practice, gap identification.
- Score Card—assess how we are doing to get aligned with national standards of suicide prevention data. Focus on how to improve this.
- Improving the data literacy and competency of people across the state.
- Build the capacity of the field to be more data driven.
- Data coordination—what metrics are most important to collect on a local level and how do we feed these into the larger scheme of things. Review the data dashboard on a routine basis.
- Who holds the task of providing data sources and the data dashboard for us to review.
- Think tank brain trust for individual research presentations.
- What are the universe of data metrics? How does this connect - protective and risk factors.
