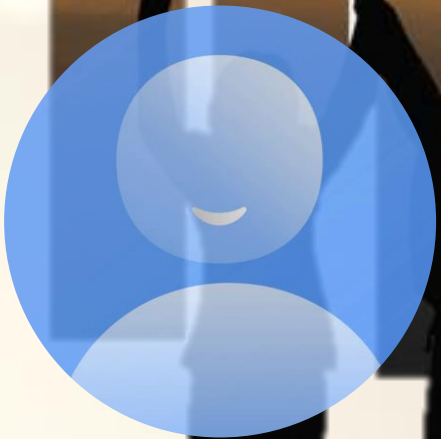

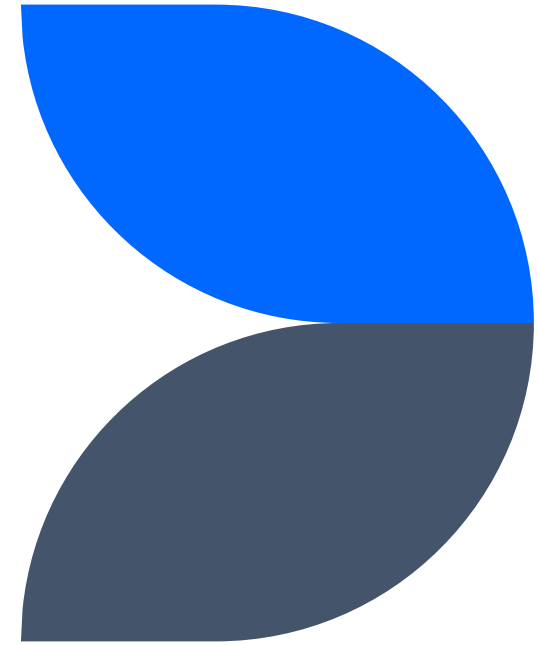

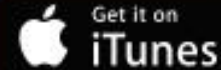

Tip Levels

Tips triaged/assessed for level of severity, timeliness, and assistance needed

CRITICAL: Immediate or imminent threat of violence, potential self-harm, potential harm or criminal acts. Law enforcement is notified. *2-minute notification.*

URGENT: Ongoing or past incidents of violence, self-harm, or criminal acts. High potential for occurring again. *10-minute notification.*

75%

STANDARD: Peer to peer interactions that schools typically deal with (student arguments, school rule violations). *1 hour notification*

OTHER: Tips that don't meet the criteria above.



Over 11,100 Tips Received*

- 30% - Bullying/Harassment
- 13% - Mental Health Concerns (*Suicidal Ideation, Self-Harm, Depression*)
- 13% - Alcohol/Drug Concerns
- 10% - Threat to safety (Fighting, gang activity, assault)

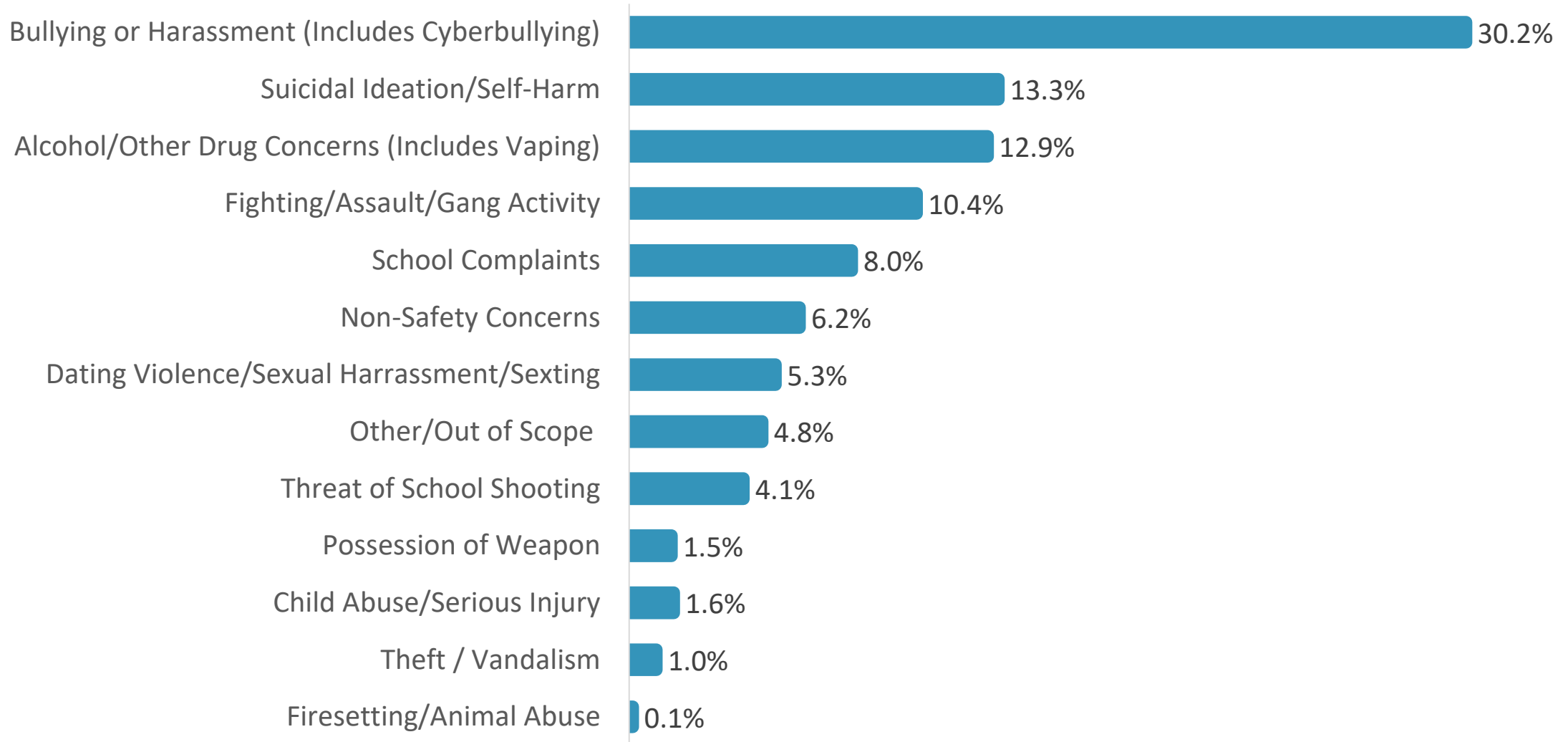

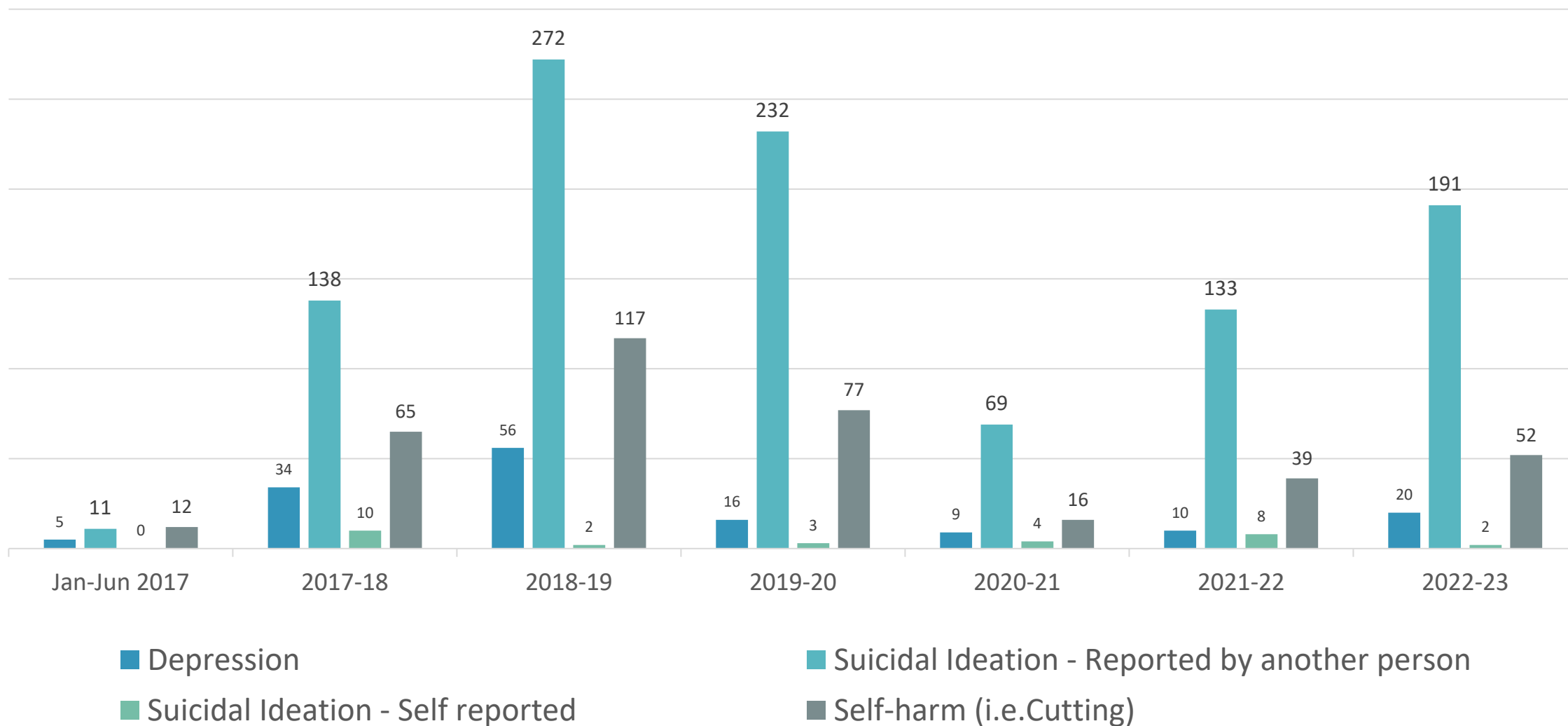
Incident Types Reported to SafeOregon

Based on total number of incidents reported since program inception (n=12,026)

Tips received may include more than one type of incident.

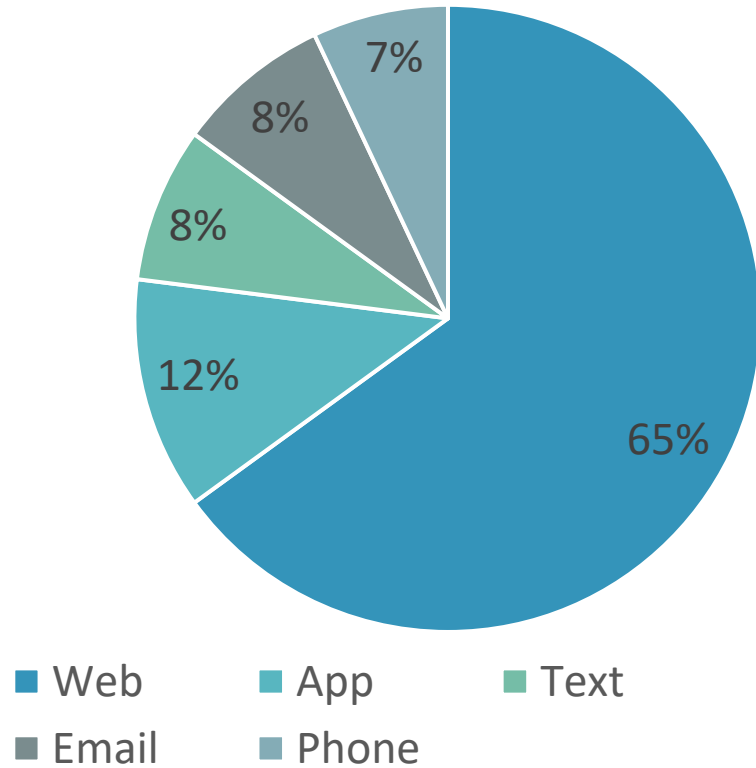


Breakdown of Incidents Related to Mental Health Concerns Reported to SafeOregon by School Year

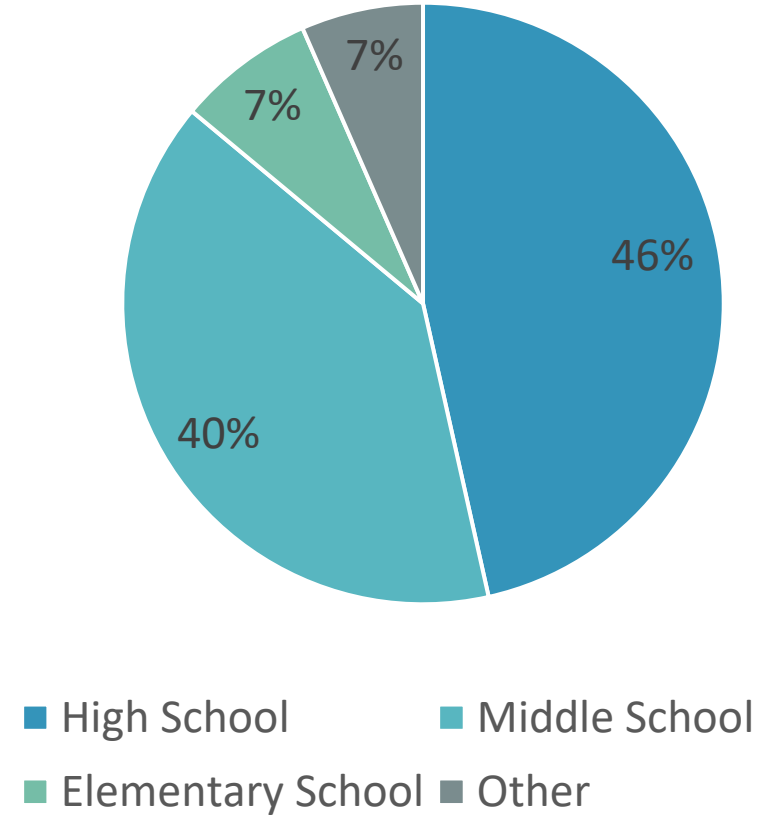


Tips may have multiple incident types. All incident types based on tipsters perception of the tip information prior to investigation. Totals do not reflect outcome of incident types after investigation.

REAL SAFEOREGON TIPS

*"She has been suffering with **mental issues** for a while now but just recently she started talking about how this is too hard, and **she doesn't want to do this anymore.**"*

*"Big groups of people go into the library girl's bathroom, and some will **vape** out in the open or in stalls."*

*"I get **bullied** a lot and causing me to think about committing **suicide.**"*

*"He has a **gun** in his bag and is threatening to shoot. I saw the gun."*

*"...**kicked** me in the back of my leg there's still bruised marks on my back leg also today he started **choking** me until I was light headed and pushed me so hard I almost **fell face first** into the concrete."*
