"Culture should be at the forefront of our thinking when we discuss suicide prevention, intervention, and postvention. We all come from diverse backgrounds with significant differences that are fundamental to consider in our interactions in providing support, resources, and services. During the summit, we will seek to understand suicide and suicide attempts within the context of the person's culture, subculture, generational differences, social position, language, religion/spirituality, cultural characteristics, gender identity, values, and beliefs that can create or function both as risk factors in seeking support for traumatic and emotional disturbances as well as function as protective factors that provide support and encourage help-seeking behaviors and attitude."

			Q: Are we trying to have shared measures across trainings? A: Yes. Part of this is a data harmonization issue because different trainings ask for different metrics so we will need to figure this out.
			 Q: Kathy thinks it's important to see what happens with the workforce is trained and also when the community is trained. There are some communities that are more remote that others in Clackamas county and she is trying to go to these different areas and train different sectors that include both professionals and volunteers. A: John says that we need to take a sector approach and we can look at settings within those sectors. Shanda says it's also important to see where the trainings are being built into the

different settings so that when there is turnover there is a plan
to keep people trained.
Q: Sandy is wondering if these processes and measures will be able to tell us if they are causing a change in youth behaviors. She would like to see if we can find some level of correlation between the two and also see what else is going on in the community. A: John says it is important to look at protective and risk factors and see how those are changing. For example, connectedness. Are youth feeling more connected to peers or have someone they can go to when they need support. How is that changing, improving or does it need more support?
Q: Elissa says that she understands the importance of getting process measures in place however we need to hear what is going on at the direct level. Are people using the trainings? etc. Can we create some pockets to get that data and information sooner, before the process measures are finalized. So that advocacy for the work can continue. A: John says that follow-up surveys are one way they want to work towards getting this information. So far, these are asked for with no incentive and we only have a 30% response rate. Ideally, these are ongoing and we can see how they are using data to onboard policies.
Annette connected this to the Workforce Committee and the concern they have around the data that is collected from SB 48 and now HB 2315 as the information is very basic – we don't

		know what training they are taking and also if the training is even appropriate for their level of care providing. Annette said that she is hoping the Workforce committee can finalize some ideas for what they would like to ask for they can bring it to this committee for feedback and input. John said the metrics should be a regular agenda item moving forward. Kathy asked what that timing would look like. He said

Potential tasks for Data & Eval Committee (brainstorm ideas)

• Catalog a list of data sources.

- Learning collaborative for people working in suicide prevention who are working in data, best practice, gap identification.
- Score Card—assess how we are doing to get aligned with national standards of suicide prevention data. Focus on how to improve this.
- Improving the data literacy and competency of people across the state.
- Build the capacity of the field to be more data driven.
- Data coordination—what metrics are most important to collect on a local level and how do we feed these into the larger scheme of things. Review the data dashboard on a routine basis.
- Who holds the task of providing data sources and the data dashboard for us to review.
- Think tank brain trust for individual research presentations.
- What are the universe of data metrics? How does this connect protective and risk factors.
