Why focus on healthcare provider training?

Of people who die by suicide –

- 77% of individuals had contact with their primary care provider in the year before death
- On average 45% of individuals had a contact with primary care provider in the month before death
- National organizations and governments concur training healthcare professionals is a critical suicide prevention strategy for
- Patient Safety and Provider Well-Being

States Take Different Approaches to Healthcare Provider Training

Encourage - Require

- Selected professions, all healthcare providers
- Duration, Frequency, Topics Covered

Training Options

- Requires SP training for nurses
- 1 contact hour suicide prevention (general)
- Kentucky traumati
- I contact hour: chronic toxic and secondary traumatic stress, pathway to care for nurses at risk for suicide

August 2022, nursing programs – suicide prevention as part of curriculum

Physicians are required to complete SP training, topics such as:

- Risk factors associated with suicide
- Process of screening and assessment to determine risk for suicide

Nevada

- Management of patients at risk for suicide
- Treatment modalities that may be used for persons at risk for suicide
- Approaches to engaging other professionals in suicide intervention

Washington

- Early adoption, legislation required SP training across healthcare provider professions
- One the first states and most comprehensive list of providers
- Duration and frequency varies, dependent on healthcare profession
- Implementation challenges
