Quick Legislative Update -AFSP Advocacy Action Day

HB 2538

Directs the Oregon Medical Board to require physicians and physician associates to complete continuing education regarding lethal means counseling.

HB 2845

Requires an appropriation to the Department of Veterans' Affairs from the General Fund for suicide prevention supports and workforce reentry.

HB 3127

Requires medical certifiers and medical examiners to use the state electronic reporting system to report deaths to the Center for Health Statistics.

- Polk County started the coalition in 2016
- Partnership between Marion and Polk Counties began in 2019
- Ebbs and flows
- Late 2022 started to see growth
- Current status



The Focus

- Started with a focus on training
- In late 2022 focus shifted to coordinating resources and outreach and education
- Created a steering committee of community partners to help guide the direction of the group
 - S.W.O.T analysis and action plan each year
- Focusing on growing the Coalition with representation from many diverse groups
- Created a planning workgroup for outreach

The Details

- Quarterly meetings-rotating between Counites
- Steering committee meets twice a year
- Planning committee-working group that meets monthly
- Participants from schools, hospitals, veteran groups, older adults, community groups, youth serving organizations, 988.




What is childhood trauma? Commonly called Adverse Childhood Experiences (ACEs), are potentially stressful events that can have negative, lasting effects on health and well-being.


Adverse Childhood Experiences





What is trauma's impact?

Disrupts development of brain, brain chemistry, and nervous system.



Disrupts development of organs, circulatory system, immune system, inflammatory response system

Impairs social, emotional, and cognitive development Weakens ability to regulate emotion and manage impulse control

Why school leaders care about trauma •Decreased reading ability


Lower GPA

Increased drop-out






Why school leaders care about trauma

A traumatized kid sees the world as a dangerous place, including school. Unfortunately, many adopt behavioral coping mechanisms that can frustrate educators, evoke exasperated reprisal.



Reactivity and Impulsivity Aggression Defiance Withdrawal Perfectionism



The next day in school...

Are these children: Hungry? Falling asleep in class? Doing their homework? Failing a test? Staring off into space? Having an outburst?





The next day in school... Our schools strive to be "Trauma-sensitive." Safe places where kids can build positive relationships with adults and peers, learn to manage their emotions and behavioral responses, and find academic success

Handle With Care: History

- 2009 Office of Juvenile Justice Survey
- 2010 Defending Childhood Initiative
- 2011 West Virginia's Children's Justice Task Force formed a subcommittee to look at programming
- 2012 Developed the HWC program
- 2013 Piloted the HWC program
- 2015 WV State Police launched HWC statewide
- 2019 65+ cities have launched HWC



Handle with Care

In a new program called "Handle with Care," area law enforcement agencies are giving local schools a heads up when they learn a student has been exposed to trauma.

The schools aren't given any information about the event, but are just told the student needs to be handled with care.

Student's name, D.O.B., and the phrase "HANDLE WITH CARE"

How Handle with Care Works



HWC

The officer then emails a Handle with Care notice regarding the child to the designated school district personnel.

When an officer is called on a scene and sees a child who has experienced trauma, they gather info about what school the child attends.

School district personnel forwards HWC notice to child's school building admin, where child's teaching staff are informed to "Handle with Care"

Teaching staff and school personnel provide: classroom interventions, awareness, observation and/or support

Handle with Care

What It IS:

•Notification system between law enforcement and the school district.

•Students exposed to potentially traumatic events.

•Ensures students exposed to trauma receive appropriate interventions.

•Supports staff in managing difficult student behaviors that can stem from trauma.

•Gives staff the opportunity to get ahead of potential challenges in the classroom.



Handle with Care

What It Is NOT:

•A rumor mill. HWC notifications will only go to designated school personnel.

•An opportunity to ask questions. Staff who receive an HWC notification will respect the student's right to privacy.

•A guarantee that a mandatory report will be necessary. An HWC notification does not mean the child is unsafe at the home.

•An invitation to "rescue" the student. Staff will focus on healthy support including setting boundaries, empowering students to do what they can for themselves, and recognizing when students need a break.



Implementation:

- Minimum key stakeholders included schools, law enforcement agencies, and mental health providers.
 - Commitments came from local leaders (school superintendents, principals, police chief, sheriff, mental health providers).
- Liaisons/Champions: school, law enforcement and mental health providers designated a few people to serve as the Liaisons/Champions for their organization.
- The Josephine County Suicide Prevention Coalition, with support from SPC Angela Franklin, provides ongoing assistance.

•With guidance from Wasco Co HWC stakeholders, protocols developed and MOUs were signed by all stakeholder organizations.

•Schools and LEAs provided w/ HWC implementation materials for training staff (includes 1 hr training)

•Monitor and review HWC for each school district and school, (quarterly), with support from Josephine Co Suicide Prevention Coalition HWC Workgroup

Data Collection and Review:

•School District HWC Lead keeps a spreadsheet of HWC notices: Student ID, HWC Notice Date, Student Grade, Student School

•School Designated HWC Lead keeps a spreadsheet of: Student ID, HWC Notice Date, Teachers Notified, Staff Notified, Referrals to Internal/External Supports

Gathering Information from Teachers for Program Review (Quarterly)

How many students were identified as needing HWC support?

•What changes were noticed in students after they were identified for HWC support?

•What steps were provided for additional support to students identified for HWC support?

•What resources were used to address student's needs?

•What would help meet the needs of students identified for HWC support?




