- We need a temporary co-chair while Maryanne is on maternity leave.
 - Staff will put it out to members to get folks to the meeting and to task for volunteers.
- Options for our time today:
 - What does it look like for us to do equity work in the current landscape? or
 - How can we get engagement and re-engagement in the subcommittee? or
 - Work on the Alliance orientation process again?
- Question to OHA how concerned do we need to be about this work?
 How is this being talked about at the state level? Are our state funds secure with current federal slashing DEI work?
 - Our governor and general attorney are not budging Example requiring folks to take training on what to do if ICA asks for documents.
 - Lots of questions.
 - Almost \$2.5 of \$10 million for our budget is Federal funding.
 *We should be conscious and thoughtful around what we are talking about and how strongly we are saying anything right now.
 - Our federal learning collaboratives have been cancelled for at least three months - but named as indefinite. (most federal grant meetings and learning collaboratives have been cancelled for the transitional period)
 - OHA is planning and building for unchanged funding knowing this is a weird time.

- Are we concerned about the cultural infusion work we are embarking on?
 - Banking on the legislative mandate to update the YSIPP carrying this work through
 - The biggest concern is protecting people/groups that may be targeted.
 - Dr. Hathi, Director of OHA has not shifted course
- Comment we may need to expect a narrowing of what we can spend funds on and also perhaps think about government tracking of organization communications (we may need to think about what language we use to make the work less searchable and harder to target)
 - Maybe we do need to think about how we could swap out general funds so that we aren't impacted by narrowing of scope for funds.
 - Recent conversation with GLS grant monitor agent from SAMSHA: when asked directly about language in the new budget - told to keep it as is right now and move forward with work as planned.
- We can come back to this conversation each month as it will be ongoing
 - Navigating the current landscape
- AOCMHP will bring the AI policy to the group to discuss. Staff will be attending an AI and equity learning event and will bring what they learn to the group.
- Re-engagement and New Engagement Personal check ins with folks who are not here but have been in the past and invitations to new folks, especially Alliance members.
