8:30		The meeting began with Lucina confirming the agenda and minutes were attached to the meeting invite, and Mary welcomed attendees, including guests from the Latino Network. Mary acknowledged past harm and outlined accountability actions, including reinstituting community agreements and reviewing mission and equity statements. The group heard from the Latino Network, who presented on the impact of ICE enforcement on youth and families, emphasizing the need for support in their communities. The presentation was not recorded, and instead, a simplified slide deck with resources would be shared.

Your 5 Constitutional Rights:

- **Right to remain silent** the only person that you have to talk to is a judge in a court room
 - Have to say loud and clear "I have the right to remain silent" in English.
 - o "I do not consent to this search"
 - "Am I free to go" This is all they should say over and over
 - Do not resist or try to run away
- Right to NOT sign documents will lie and try to intimidate to sign
- Right to be represented by an attorney if you are detained (we have the ECHO program in Oregon so that everyone can access)

*Recording the interaction is most powerful thing we can do! Listen and stay safe – if they ask to step back do so – do not get between agents and person. *Write down everything immediately if you can't record.

*When people know their rights and exercise them cases look very different than when they don't. Even if they are going to violate their rights – this is a protection.

Right to ask what agency they work for?

ICE lies and uses tactic of lying that they are police

Could be in any vehicle – might have additional accessories that look like law enforcement – arrive in groups – because of state sanctuary law they are renting vehicles form out of state

Do not run – they are not showing up randomly – they have done an investigation and looking for someone specific– there are more agents around the area so running is not helpful and dangerous.

*Know the building protocol and your role in enforcing those protocols Emergency alerts for ICE presence Partners need to be in the loop

Oregon sanctuary Law

Protected by sanctuary law added in 1987 (first state to have this) any agency that orks for an agency that receives state funds cannot collaborate with ICE to help enforce immigration law unless there is a warrant signed by a judge.

State-funded employees are only doing their jobs – not stopping their work
